## **About Us**

Upon declaration of the "War on Poverty," which resulted from the Economical Opportunity Act of 1964, President Lyndon B. Johnson created what has grown to over 1,000 Community Action Agencies Across the nation – together Helping People, Changing Lives.

Since our creation on April 14, 1965, Community Action Partnership of Greater of St. Joseph has been partnering with low income families, individuals and communities in Andrew, Buchanan, Clinton and DeKalb Counites to help them achieve economic and social stability; to build community, and to advocate for social and economic justice.

Community Action Partnership of Greater St. Joseph provides assistance for low-income individuals and families in the form of utility assistance. We work to create safe and affordable housing opportunities through our Housing Development program. Our Head Start and Early Head Start programs provide early childhood education, nutrition, mental health, and social services to low-income children and their families.

## **Head Start**

Head Start Preschool and Early Head Start continue to support the physical, mental, social, and emotional development of children from birth to age 5. In addition to education programs CAPSTJOE's Head Start program provides children and their families with comprehensive services. Head Start encourages the role of parents as their child's first and most important teacher.



#### **Our Impact**

Head Start Preschool is funded for 207 slots, and served **248 children**. Early Head Start is funded for 110 slots, and served **162 children** and **22 pregnant women**.

85% of children were up to date on immunizations, while 89% of children were up to date on dentals.

**37** children served were classified as homeless, while **35** children served were in foster care.

352 families

were served through Head Start Preschool and Early Head Start services.



# **Utility Assistance**

CAPSTJOE's Low-Income Home Energy Assistance Program (LIHEAP) provides financial assistance to low-income families with their heating and cooling cost. CAPSTJOE's Low-Income Household Water Assistance Program (LIHWAP) provides financial assistance to low-incomes families with their home water and sewer cost. Both programs play a vital role for families with fixed incomes, with over 50% households served being those of elderly or disabled individuals.



#### **Our Impact**

In fiscal year 2024, CAPSTJOE received **5,195** applications for energy assistance.

\$1,446,340 was provided in crisis energy assistance to 2,165 households.

**2,115** pledges were made for Winter ECIP and **2,140** pledges for Sumer ECIP.

**319** pledges were made for water assistance.

5,518 individuals

benefited from energy assistance by preventing or restoring heating and cooling services.



# **Family Service**

CAPSTJOE's Family Service Department includes programs and services designed to reduce poverty, revitalize low-income communities, and empower low-income families to become fully self-sufficient. Community Services Block Grant (CSBG) funding serves as the core funding for the Family Services Department. CSBG funds are leveraged in collaboration with other programs to accomplish a while family approach. Below are the outcomes achieved by Family Service's programs and services.



#### **Our Impact**

22 carseat referrals provided

307 households received emergency utility assistance

14 individuals received transportation assistance

16 birth certificates obtained for individuals

3 state identifications obtained for individuals

196 hygiene kits distributed

25 households received housing assistance

**97** appointment rides were provided.

550 food boxes

were distributed to families.





CAPSTJOE is committed to engaging the community in the war on poverty. Part of CAPSTJOE's efforts include advocacy for low income individuals and families. One of the most powerful tools CAPSTJOE has for engaging the community in the fight against poverty is community poverty simulations



#### Our Impact

4 poverty simulations were hosted to varies community groups and organizations.

2 community events were hosted to connect parents with state legislators.

CAPSTJOE participated in **20** resource fairs, providing information on programs and services to the community.

251 individuals

participated in poverty simulations gaining a better understanding of poverty and the challenges families face. CAPSTJOE's SkillUp is a free program that helps SNAP recipients get help with skills, training, and employer connections to get a job (or a better job). Our team works with individuals to create individual plans to help each person reach their goals and start a new career.



#### **Our Impact**

8 individuals gained employment with a living wage.

28 individuals were enrolled in a variety of training programs.

15 individuals received resume assistance.

45 individuals

were enrolled in SkillUp.



## Housing Development

Finding safe, decent, and affordable housing is a serious challenge for lowincome families. CAPSTJOE has developed more than 460 new housing units for lowincome households throughout our service developments These include area. single-family homes apartments and comprised of both new construction and rehabilitation of existing properties within our service area.
